Estimates for works to be carried out prior to the installation of play equipment at Ravenstonedale have been received. Works include reinstatement of the beckside wall, erection of a safety barrier alongside the beck, removal of some trees and clearance of undergrowth. It will also be necessary to improve the access path and create a ramp to the bowling green level to facilitate access by wheelchairs, pushchairs, etc.

Applications for grant aid towards the costs are now being processed.
