#### **Grasscutting 2010**

A quotation for Grasscutting throughout the village and Newbiggin-on-Lune had been received from A Kirby, Kirkby Stephen who has carried out the work satisfactorily for several years. The areas will now include the former High Chapel graveyard and the Village Shrubbery.

It was **resolved** that Mr Kirby be instructed to carry on the fortnightly service.

#### **Ravenstonedale War Memorial**

The kerbs and plinth surrounding the War Memorial in Ravenstonedale Churchyard are in need of repair. A quotation to carry out repairs has been received from Able Memorials who have previously carried out remedial works in the churchyard.

It was **resolved** that Able Memorials Ltd be authorised to carry out the repairs for the sum of £385 plus vat.

#### **Ravenstonedale High Chapel**

It was reported that a draft sale document had been received from the Synod's solicitors. The document has been passed to the Council's solicitors for action.

#### **Parish Council Insurance**

A new specialist provider – Aviva (formerly Norwich Union) - appears to provide superior cover plus playground inspections at best rates. Clerk to obtain further details of cover and comparative quotation.

## Children's Playgrounds

## UECP

## Public Participation

The question was put "should Scandal Back be fenced to prevent access by children". It was noted that discussion and a risk assessment on this point is ongoing. Mr Michael Metcalfe-Gibson asked "who is responsible for the beck at Town Head which is encroaching on to common land by erosion". Clerk to make enquiries of Environment Agency & Eden Rivers Trust.
