

## RAVENSTONEDALE PARISH COUNCIL

### Minutes of a Meeting held on Thursday 10<sup>th</sup> February 2011 in Ravenstonedale High Chapel Room at 7.30pm

**Apologies for Absence** had been received from Cllrs Paul Capstick & Alison Morriss, County Councillor Peter Thornton and District Councillor George Boustead

#### **Declarations of Interest**

There were no declarations of interest in any item on the agenda.

**Minutes of the Meeting** held on Thursday 13<sup>th</sup> January 2011 had been circulated and were signed by the Chairman as a correct record.

#### **Upper Eden Community Plan Group**

It is proposed to formalise the group by the creation of a Community Interest Company. A Draft copy of the Memorandum and Articles of Association were presented at the UECP meeting on February 3<sup>rd</sup>. The document needs to be ratified by each of the member parishes to validate it.

Ravenstonedale Parish Council studied the document at length and made the following observations;

It was considered that the objectives laid out in the draft Articles of Association are beyond those of the original concept of the Group and exceed the remit afforded to parish councils by current legislation. [Parish Councils includes Town Councils and Parish Meetings].

It was considered that the function of the UECPG should be to act as a cohesive voice to lobby existing agencies for action on matters of common interest such as Highways, Broadband, etc. and that such was the original concept.

These Articles appear to promote diversity into fields such as provision of housing, employment and financial relief, all of which would duplicate and dilute the efforts of others.

Within the document there is no definition of "Member" or the qualification for membership. This tends to create confusion throughout.

Presumably, as a Registered Company, it will be necessary to employ a Company Secretary and a Financial Controller. There is no mention of staff or financial viability.

There has been no financial forecast or business plan for the proposed company.

There have been no published accounts for the UECP since its inception and the engagement of a project officer.

The Group must take care to ensure accountability and transparency.

It is not clear how the proposed CIC, with one Director from each member council, may make decisions which would be binding upon those councils and still be compliant with **Local Government act 1972 section 101** which states that "**a Local Council may delegate decisions to a committee**" (see the Act for full wording)

A committee **MUST** comprise more than one member therefore the appointed Director would need to refer recommendations back to his council for confirmation before they may be considered as resolutions.

A substantial number of amendments to the draft were considered essential if the Articles were to be agreed (Appendix 1) on the assumption that compatibility with LGA 1972 s101 is achievable.

It was **resolved** that Ravenstonedale Parish Council defer a decision on formation of a Community Interest Company until the foregoing observations are clarified.

### **Neighbourhood Plan Pilot Project Concept**

This item related to the Localism Bill currently under discussion in parliament. UECP had hoped to initiate a plan in partnership with Eden District Council. EDC, however, did not support the proposal to apply to become a pilot area for the Neighbourhood Planning part of the Localism Bill. This was decided by the Executive Committee at their meeting in Penrith on Tuesday 8<sup>th</sup> February. UECP may elect to submit their own bid to run the pilot on a community level.

### **Ravenstonedale Local History Group**

The first presentation on the "Milner family of Ravenstonedale" was made by Val & Steve Fermer. A programme of monthly evening meetings and events is being planned. Christopher Read will present "Growing Up in Ravenstonedale in the 1940/50s" on Tuesday 1<sup>st</sup> March.

### **Ravenstonedale High Chapel**

A Planning Application has been submitted for Listed Building Consent to remove pews etc. Consultations have been made with EDC Conservation and Planning Officers. Garsdale Design Ltd is preparing plans for installation of toilets etc.

### **Broadband in Ravenstonedale**

A survey of existing download and upload speeds facilities is being conducted on the ravenstonedale.org website. A map of existing reception in the local area is being created. Residents are urged to respond.

## **Highways**

Wall, Land & Trees opposite Scar Gallery. The Chairman and Clerk had a meeting with Rob Lawley, area engineer with Cumbria Highways to establish responsibility for the repairs to the roadside wall. There is no known owner for the land beyond the wall. Mr Lawley has noted the problem but, as previously mentioned, Cumbria Highways has just resumed responsibility from Capita and the department is in a state of flux until budget has been established.

## **ACRE – Hallmark Scheme**

Action with Communities in Rural England (ACRE) runs a "Hallmark" scheme which aims to set standards for village halls. This includes the premises, the facilities offered and the management.

The Clerk has attended a training course for volunteer inspectors, run by ACT (Action with Communities in Cumbria – formerly VAC). Knowledge of standards expected, management, etc should be of value in the development of the High Chapel as a Community & heritage Centre.
