#### **Declarations of Interest**

**Minutes of the Meeting** held on Thursday 13<sup>th</sup> October 2011 had been circulated and were signed by the Chairman as a correct record.

#### **Ravenstonedale – Newbiggin-on-Lune Cycleway**

Following several years of lobbying and negotiation by the parish council, Cumbria Highways have announced that they will start construction in January/February 2012.

#### **Ravenstonedale High Chapel**

The future of the pulpit, lectern and altar rails has not yet been resolved despite it having been offered to a number of church and chapel bodies, including Westminster College, Cambridge, the Historic Chapels Trust, URC Synod NW, Carlisle Diocesan Board and numerous individual parishes.

It was **resolved** that the proposed disposal should be advertised locally.

The structural survey carried out three years ago has been updated in order to facilitate grant applications. The surveyor from R G Parkins & Partners who carried out the original survey has completed the work and submitted both written and electronic versions of the report.

#### **Parish Precept for 2012-2013**

The Clerk presented a draft budget for discussion. It was **resolved** that the precept for 2012-2013 would remain unchanged at £16,000.00.

## Boundary Commission for England

The Boundary Commission for England had published a recommendation for a Review of Parliamentary Constituencies in Cumbria. The government requirement is that the total number of Members of Parliament representing Cumbria be reduced from six to five and that each new constituency has approximately the same population number.

It was considered that the Boundary Commission proposal was a less than ideal solution. A local cross-party group had devised an alternative counterproposal. This would have Ravenstonedale in a new Westmorland & Lonsdale constituency.

It was **resolved** that Ravenstonedale Parish Council should recommend acceptance of this proposal to the Boundary Commission. A map of the counterproposal is appended to these minutes.

## Superfast Broadband in Ravenstonedale

Ravenstonedale's Broadband Champion, Libby Bateman, announced that plans were well advanced to install fibre connections to properties in the Fell End area and that government funding has been secured for the project.
