Election of Chairman for the year 2012-2013

The Chairman, Councillor Ernest Leach invited nominations for the position of Chairman for the ensuing year. Councillor Ernest Leach was nominated and elected unanimously. Cllr Leach signed a Declaration of Acceptance of the Office of Chairman.

Election of Vice-Chairman for the year 2012-2013

Councillor Leach took the chair and invited nominations for the position of Vice-Chairman.

Cllr Hilary Law was proposed and elected unanimously. Cllr Law signed a Declaration of Acceptance of the Office of Vice-Chairman.

Declarations of Interest

There were no declarations of personal or prejudicial interest in any item on this agenda.

Minutes of the Meeting held on 8^h March 2012 had been circulated and were signed by the chairman as a correct record.

Annual Parish Meeting 2012

The Annual Parish Meeting for Ravenstonedale 2012 was held at 7.30pm on 10th May 2012 immediately before the Annual Meeting of the Parish Council.

Two members of the public attended as well as six parish councillors, the parish clerk and a district councillor.

There was a discussion on the relationship between Ravenstonedale Village and Newbiggin-on-Lune. It was suggested by the members of the public that the parish name should be amended to Ravenstonedale and Newbiggin-on-Lune for greater equality. This was countered by the argument that the parish has been Ravenstonedale for centuries and included also Fell End and Bowderdale, Weasdale etc. A longer title would also be too cumbersome and confusing.

It was noted that the interests of Newbiggin were well represented on the parish council by having three out of the seven parish councillors. Three others reside in Fell End and only one in Ravenstonedale village.

There being no further issues, the meeting closed to be followed by the AGM.

Ravenstonedale Community & Heritage Centre

The Table Top/Garage Sale held on Sunday 6th May had raised more than £300 towards the building renovation and improvement fund.

A partition in the upper meeting room to accommodate the archive and equipment of the Ravenstonedale Parish History Group is almost complete. This will enable the remainder of the room to be used without disturbance of the history archive and give security for computer and other equipment.

Highways

Letter received expressing concern about traffic speeds at Town Head and suggesting a 20mph speed limit through the village. This has been passed to Cumbria Area Police Team at Penrith for their comments.

Proposed works to Irish Ford at Town Head.

Following years of complaints about flooding Cumbria Highways are now proposing to construct new structure (presumably bridge) approximately 3 m downstream of the existing. The existing will remain in place during construction to enable access (especially emergency).
