### Minutes of the Meeting held on Thursday 14<sup>th</sup> April 2016 in Ravenstonedale Community & Heritage Centre at 7.30pm

#### **Declarations of Interest**

There were no declarations of personal or prejudicial interest in any item on this agenda.

**Minutes of the Meeting** held on Thursday 10<sup>th</sup> March 2016 had been circulated and were signed by the chairman as a correct record.

#### **Ravenstonedale Community & Heritage Centre**

A grant of £9456 has been approved by YDNPA to cover 75% of the proposed refurbishment of Upper Room.

Application has been initiated for funding towards the construction of the proposed extension/toilet block.

Quotations are being invited for repairs the useful storage shed in the graveyard which had been part demolished for safety reasons.

#### **Scandal Beck Play Area**

Attention had been drawn to the lack of a waste bin near the play area.

On inspection it was noted that a significant amount of standing water remained on the site.

It was known that a drainage scheme would, at some stage, be needed and following a particularly wet winter it is now essential. Quotations have been invited to install a suitable system.

Sources of Grant Funding to assist with the costs involved are being investigated.

Some tree works and undergrowth trimming would be desirable for safety reasons.

Advice is being sought.

Regular visual inspection reports on the play area and equipment should be carried out and a volunteer is required.

Richard Hunter volunteered to carry out regular checks on the Newbiggin-on-Lune play area which was formerly covered by Alex Watts-Tobin.

#### **Yorkshire Dales National Park**

The Clerk had attended a meeting for Parish Councillors & Clerks, hosted by the Yorkshire Dales National Park Authority (YDNPA) at the Westmorland Hotel on Tuesday 12<sup>th</sup> April 2016.

The presentations given by the Chairman and National Park Officers covered the existing work of the YDNP and implications of national park boundary extension; how the transition would be effected and what changes in responsibilities of "who does what and when". This particularly concerned the relationship between the YDNP Local Plan, Eden District Local Plan and existing Neighbourhood Plans.

It is currently proposed, subject to confirmation, that additional representation on the YDNPA Committee would include one member from Lancashire County Council, one from Lancaster City Council and one from Eden District Council. No additional Parish Council representation is proposed.
